

Please note that we wish to object to the proposed removal of a direct DART service line to Howth.

Having lived here for over 30 years and having reared 3 children on the peninsula, the direct DART line has been a fantastic method of transport for us to access Killester, Raheny, the city centre itself and the Southside, for education purposes, for work, medical appointments, social & pleasure, visiting friends and relations.

There is an increase in population in this area - the apartments on the way into Howth village are not inhabited currently, the apartment build on the site of the Baily Hotel in Howth village has barely begun, so why persist with downgrading the public transport system to the peninsula while population is increasing?

The DART service can be extended to Drogheda but it is still possible to maintain the direct DART service to Howth so we would request that you do so as a matter of priority. Suggesting that we alight at Howth junction to board a shuttle to Howth is not reasonable. The number of steps to be negotiated at the junction is not feasible for an elderly population, or for those with disabilities or those with young children and a buggy. Also, please note that there is a continual list of stations where lifts are out of order on the DART line. The state has a duty of care to its citizens but seems to have forgotten this.

The shuttle service operating every 10 minutes in both directions will be a disaster as it will cause a huge amount of disruption to traffic due to the increased closing of the level crossing gates. The traffic assessment submitted by Irish Rail as part of their application shows that longer closures of the level crossings will result in more traffic congestion. Furthermore, the traffic study states that traffic queues on Baldoyle Road could be up to 59% longer than they currently are. (Appendix A6.1Dart +Coastal North Level Crossing Assessment page 29). The increases traffic backup is almost certain to impede the flow of traffic at Sutton Cross. What a mess!

Have you considered the negative impact the loss of the direct Howth DART service will have on local businesses in Baldoyle, Sutton and Howth? People use the direct dart line to come to work here in this area. Removing this service will add to the time travel involved and may lead to them choosing to drive

instead. Given that the National Sustainable Mobility Policy sets out a framework to 2030 for active travel and public transport to support Ireland's overall requirement to achieve a 51% reduction in greenhouse gas emissions by 2030, removing the direct DART serve to Howth will not help.

We request that An Bord Pleanála call an oral hearing.
