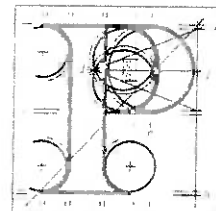



DART + COASTAL NORTH *Railway Order 2024*

We oppose the Dart + coastal north plans

I, Carolyn O'Laoire, 146 Dublin Road, Sutton, D13 C5P2, oppose the above plans.

I am joined by a total of 62 signatories, who are Parishioners of St. Mary's Parish, Howth, and who object for the following reasons:

1. Since the plan is to operate the shuttle service every 10 minutes it will result in the level crossing barriers in the area (Sutton Station, Baldoyle Rd, Lauder's Lane, Howth Lodge) being closed for up to 30 minutes in the hour.
2. The above closures will result in greatly increased traffic jams in Baldoyle, Station Road and backing on to the main road and at Sutton Cross.
3. The inconvenience for Dart commuters will likely result in more people choosing to go to work in their cars, contrary to the Government's original intention!
4. The plan will have a negative impact on those with disabilities and mobility issues through having to change at Howth Junction where the lifts are so often out of order.
5. Anxiety has been expressed regarding anti-social behaviour at Howth Junction.
6. The increased road traffic will slow the buses in the area and make it virtually impossible for Ambulances getting access in and out of Howth.
7. It will make journey times longer for people travelling by Dart towards Howth/Sutton for schools and work.
8. Local Businesses will experience difficulties with regard to slower deliveries and staff taking longer to get to work.
9. Howth is one of the main tourist attractions in the Dublin area. Will tourists still come out to Howth if the direct Dart service ceases? What impact will this have on local businesses and restaurants?
10. Planning permission for all the new apartment blocks being built in Howth was based, among other things, on there being direct access to the city centre by Dart.
