



As a resident of Malahide Marina Village, I object to the proposed turnback project being proposed north of Malahide station on the following points:

Landscape and visual landscape – The proposed turnback project north of Malahide station will have a negative impact on visual amenity, including a significant negative impact on scenic views of Malahide Estuary. The impact of these changes will significantly alter the views from properties in the vicinity of the turnback. Furthermore, the aesthetic of the estuary could be altered, potentially affecting property values and the scenic views that contribute to the charm and appeal of living by the estuary.

The construction of a permanent raised walkway, handrail, and lighting will also affect the visual amenity for residents who currently have a view of the estuary. There are concerns that trains could be stationary for some time while there is a driver changeover.

There are concerns of the adverse effect of light pollution on wildlife and ecosystems in existence in Malahide Estuary SAC.

Construction impacts Noise and vibration during the construction phase will require the existing OHLE and signalling systems to be modified with new OHLE masts typically

every 40-50 metres along each side of the tracks, excavating to allow for pilling rig access, pilling works over several months, resulting in a negative impact to residents adjoining the work sites. It is envisaged that construction works will be by day (especially at weekends) and some by night. It will also necessitate some nighttime weekend work. All of this will result in a negative quality of life for all residents, those who are elderly and those who work from home.

Access roads and traffic during construction

A construction staging area next to the water treatment plan will result in the access road not being unavailable during these construction works and temporary access to the Wastewater Treatment Plant is proposed through the existing Marina Village Road. This will have a significant negative residual impact on the residents and commercial units in the Marina Village with increased commercial vehicles and construction traffic congestion on the Marina Village Road.

Impact on wider community

The proposed traffic access route will have a negative impact on the wider community with main construction traffic going through Old Street and James' Terrace, where there are already significant traffic constraints. It is suggested that larger vehicles could require the removal of on-street parking in the village, and even a possible 2-way traffic configuration on James Terrace that is currently a 1-way road. Such movement of construction vehicles would negatively impact community facilities such as schools and places where people live, shop or recreate.

I would suggest that Irish Rail re-consider option 5b that was previously eliminated as a preferred option based on the following factors:

• Option 5b (sees the turnback facility re located to the north of the existing estuary crossing) would deliver TSS from a Train operations functionality perspective.

 Indeed, it was called out in Annex 3.4 – Technical Optioneering Report Appendix A: Detailed MCA Table, that option 5b option has some comparative advantage over Options 2a and 2b as there is less loss of trees and hedgerows and less visual impact for properties east of the railway.

• Regarding noise and vibration, this option is not near sensitive receptors for construction or operational noise making this a more attractive option for noise and vibration

• Under Transport Integration, this option 5b has no significant long term impact on other existing transport systems.

• It was suggested that one of the factors for 5b not progressing was due to it being considered overly remote with the potential to impact on driver welfare considerations.

• I would therefore ask that residents and homes owners' welfare be taken into consideration
