

Dear Sir/Madam,

The Office of Public Works (OPW) wishes to express and reiterate its overall support for the DART and Coastal North Project. The OPW is responsible for maintenance of the Matt arterial drainage scheme at Balbriggan, which falls under the statutory remit of this office to maintain under the 1945 Arterial Drainage Act.

Where development occurs in the vicinity of an arterial drainage scheme, continued access is required by the OPW for maintenance. Development should not interfere with drainage works/flood relief works maintained by this office such as channels, embankments, walls etc. This office also requests that a 10 - metre wide strip measured back from the top edge of the bank be retained adjacent to arterial drainage scheme channels to permit access for plant and maintenance. This strip should not be fenced, paved, or landscaped in a manner that would prevent access by plant machinery.

By law, the consent of the Commissioners of Public Works in Ireland is required for certain agencies proposing to carry out construction/alteration works on bridges and culverts.

The restrictions on the construction or alteration of bridges is set out under <u>Section 50 of the</u> Arterial Drainage Act, 1945.

The design and construction of bridges and culverts should be such that flood risks up- and / or down-stream are not increased, or, where no other viable options exist, are restricted to acceptable levels, and should comply with any flood risk management objectives and plans established for the area.

The restrictions on the erection, alteration, etc., of weirs is set out under <u>Section 47 of the</u> <u>Arterial Drainage Act</u>, 1945.

The modification or relocation of a watercourse, embankment or other works that has or have been completed pursuant to a drainage scheme are set out under <u>Section 9 of the Arterial</u> <u>Drainage (Amendment) Act, 1995</u>.
