

### **Development Location:**

The railway between Dublin City Centre (Connolly Station) and Drogheda MacBride Station, including the Howth Branch.

#### **Development Description:**

Railway Order DART+ Coastal North – Application by larnród Éireann to carry out railway and associated works necessary to enable the construction, operation, maintenance and improvement of the railway and provide an extension of the existing electrified rail network from Malahide to Drogheda MacBride stations.

Works include-

- Track modifications including the provision of turnback facilities at Malahide, Clongriffin and Howth Junction & Donaghmede Stations;
- Station modifications;
- Bridge modifications/improvements to facilitate extended electrification;
- Construction of substations (to facilitate the provision of power to the line); and
- Use of land for temporary construction/storage compounds.

This submission has been considered in the context of Uisce Éireann's obligations to provide public water services; Uisce Éireann's Capital Investment Plan to deliver those services, and the protection of existing and future public infrastructure to facilitate growth in those areas identified for expansion under the various Statutory Local Area Plans and County Development Plans.

#### **Uisce Éireann's Assessment/Observation(s):**

It is imperative that Uisce Éireann's infrastructure, both existing and planned, is protected and future proofed to ensure continued provision of critical services.

Uisce Éireann has reviewed the plans and particulars listed online for the subject Railway Order Application, with specific regard to the Planning Report, Chapter 10 (Water) & 11 (Hydrogeology) of the Environmental Impact Assessment Report (EIAR) and the associated drawings.

### Description of the Known and Future Likely Interactions

The applicant, larnród Éireann (Irish Rail), has engaged with Uisce Éireann Diversion's section to assess a number of proposed interactions with Uisce Éireann infrastructure. The focus of this engagement is to consider whether diversions/build overs and build near to Uisce Éireann assets are required to facilitate this project. Uisce Éireann has reviewed the plans and particulars provided and are listed in in the table below.

Please note this list is based on the best information available to Uisce Éireann and the applicant at this time. It should not be considered an exhaustive list of all diversions that may be required. Therefore, any additional diversions that may be required, in excess of those listed below, should be agreed with Uisce Éireann at the earliest possible stage, e.g. prior to the commencement of works.

Designs for all diversions are required to be agreed with Uisce Éireann at the Detailed Design stage of the project, and in all instances prior to works commencing near Uisce Éireann assets.

There is potential that works are required to facilitate the diversion of Uisce Éireann assets on third party lands. Easements to allow Uisce Éireann access to assets must be in place before diversion agreements can be finalised.

## **Connections to Public Water and Wastewater Infrastructure**

The applicant submits that no new connections to public infrastructure are required for the proposed; telecommunication equipment rooms, track panelling huts and signalling equipment buildings and it is Uisce Éireanns opinion, based on the information and plans provided that these specific proposed upgrade works to the existing train stations do not require upgraded infrastructure connections.

In regard to the proposed new connections to public wastewater infrastructure required for three substations at North Skerries, Gormanston and Bettystown, Iarnród Éireann is required to enter into a connection agreement(s) for these connections prior to the commencement of development.

### **Drinking Water Source Protection**

Uisce Éireann prioritises the protection of public drinking water sources. In this context the development proposals have been assessed for potential impacts to drinking water sources. Uisce Éireann notes the linear works occurring within a length of existing track in close proximity to Uisce Éireanns Barnageeragh water abstraction point.

The development shall not impact any Drinking Water Source and/or waters used for the abstraction of drinking water nor cause any deterioration in quality during the construction and operational phase of the proposed development.

## **Uisce Éireanns Recommendations**

In order to ensure adequate provision and protection of public water and wastewater services, Uisce Éireann respectfully requests the following condition(s) included in any grant of permission:

- 1. The Diversion/Build Over/Build Near agreements between Uisce Éireann and the applicant must be executed prior to any works commencing to/near the Uisce Éireann infrastructure.
- 2. Any diversion of Uisce Éireann infrastructure on third party lands will require easements to benefit Uisce Éireann ti be put in place.
- Any additional proposals by the applicant to build over or divert existing water or wastewater services shall be submitted to Uisce Éireann for written approval, prior to the commencement of development.
- 4. The applicant shall enter into a connection agreement(s) with Uisce Éireann prior to the commencement of the development and adhere to the standards and conditions set out in that agreement.
- The applicant shall ensure that there will be no negative impact to any of Uisce Éireann's drinking water sources and/or abstractions which may be in proximity to the development during construction and/or operational phases of the development.
