

Dear Sir/Madam,

We refer to the above-mentioned application and wish to confirm that we act on behalf of Xeolas Pharmaceuticals Limited ("Xeolas").

Part of Xeolas property has been included in the proposed Railway Order – see property reference numbers: 5005 T.1(A), 5005 4T.1(A), 5005 4T.5 (A). The lands which DART North propose to temporarily acquire comprise the majority of the carpark and circulation area associated with the Xeolas production facility located at Baldoyle Business Park.

Xeolas produce pharmaceuticals regulated by the Health Regulatory Authority (HPRA) and legal requirements associated with licensed medicines and controlled drugs. Xeolas have since 2012 operated from Hamilton Buildings in Dublin City University. They have now outgrown the facility and acquired the subject premises in June 2023. Xeolas have fitted new bespoke manufacturing equipment and are in the process of transferring all staff to Baldoyle. There is currently 100 employed and this is projected to grow to 200 by 2027 as part of a multimillion, multiannual investment plan. The plant operated by Xeolas was formerly a major processing hub for Viatras

The Xeolas plans to re-establish and enhance the plant are well underway and will involve considerable further investment and recruitment. These plants are very rare and have specific, highly sensitive requirements.

Xeolas were not notified of the proposed temporary Compulsory Purchase Order, there has been a lack of consultation between DART North and Xeolas.

Xeolas were only made aware of the temporary acquisition when the application for Rail Order was served on the 10<sup>th</sup> July 2024.

We understand that the lands are required for the following;

"Establish a temporary Construction Compound to facilitate construction of a new SEB, station improvement, platform extension, turnback works and retaining wall. The compound is located outside of current CIE lands. Access shall be via the R123. Works will include fencing / hoarding and may also include site offices, welfare facilities, storage facilities and workshops as well as storage of certain construction plant and equipment required to carry out the works. Establish a temporary Construction Compound to facilitate station improvement, platform extension and turnback works. The compound is located outside of current CIE lands. In preparing the EIAR the selection process was flawed insofar as the ownership and use of the site by Xeolas was not considered or assessed and the occupation and use of the site by Xeolas was not properly interrogated or reviewed. This is especially concerning given the adjoining property is State owned and substantially underdeveloped, and could presumably be utilized in a much less impactful manner.

The impactor the Temporary Land Tale was assessed in Table 17-6 of Chapter 17 Material Assets, Non Agricultural Properties as follows

- Impact Rating Low
- Significance of Impact Slight
- Residual Effect Imperceptible

The above assessment is incorrect and erroneous as it has does not consider the investment and use of the property by Xeolas. The proposed temporary acquisition by DART of the carpark and access will render the business unviable in so far as:

- 1. There will be no access for trucks which ship Xeolas goods and the area required for use by DART+ is in the line of container traffic to and from the warehouse, for which there is no alternative access plan proposed or available
- 2. There will be no parking for staff members in a location where public transport options are limited and little or no secure parking alternatives exist,
- 3. As Xeolas are a pharmaceutical company there is a huge emphasis on security and regulation which would be compromised as a result of the proposed acquisition, with the site being subject of extremely sensitive and important regulatory certification and approvals
- 4. The proposed acquisition would affectively landlock the facilities main source of fire protection; the water tank which is bound to the southern boundary of the site and is also bound by the proposed acquisition. This creates a health and safety issue for the operation of the facility.

The impact of the proposed acquisition will potentially result in the forced closure of a significant employer in the area and a multimillion cost to DART North.

It is the view of Xeolas that there are suitable alternative sites which could be used for the temporary compound etc required for the project, including adjoining lands which are undeveloped and would also benefit from adjoining the existing rail-line. Xeolas request that An Bord Pleana direct that the Xeolas lands (property reference numbers: 5005 T.1(A), 5005 4T.1(A), 5005 4T.5 (A)) are omitted from the Railway Order and that alternative sites be considered for the facility required.

If required, Xeolas can expand further on their submission at Oral Hearing.
