

Dear Planners.

Howth is a beautiful fishing port place with stunning sea views which is for everyone to continue to have a right of way to.

It would be very inconvenient and dangerous for many to change at Howth Junction.

There are thousands of homes being built on hill of Howth opposite howth Castle and in Howth Castle and 600 apts in Santa sabina relying in existing service as the junction at Sutton cross ishmus is too narrow for more cars.

An Bord Pleanála gave permission to build thousands of new apartments at old parsons cement factory in Howth based on the dart services remaining there.

Many people also like to avail of the beach at burrow beach each summer,;-they would be unfairly inconvenience to this right of way to one of the best beaches in Dublin.

Also there is a food festival for all displaying many fine fish dishes from the fishing port in Howth which all from Dublin like to attend and Dart are put on especially to accommodate this.

They made a terrible mistake taking out the tram in 1959. Fingal Co Co sought a submission from howth Tramway to bring back the Tram in 2016. This should be part of the infrastructure please. Please see on Wikipedia

It would be very hard to go through all the new proposed barrier down times by car and through the narrow Ishmus of Sutton cross.

The proposed infrastructure would not be there to use the dart which works perfectly as it is, from Bray to Howth. My sister lives in Bray and we meet frequently using the dart. Bray to howth is part of our Heritage.
